3. NEW BUSINESS

a. Operational Update re: Lower Johnson

In January, VicPD's Community Services Division launched "Project Connect", a four-month initiative aimed at increasing police visibility and engagement in Victoria's downtown core. The project began as a pilot in December 2019 and received overwhelmingly positive feedback from the business community and members of the public. As part of Project Connect, officers engage with business owners and staff on recommended security improvements and applicable bylaws and provide the business community with a better understanding of how and when to report incidents to the public. Project Connect was put on hold mid-March as a result of Provincial Health Orders which saw the temporary closure of many businesses.

BACKGROUND:

This report contains the financial results for the period ending May 21st, 2020, representing approximately 35.7% of the payroll year.

Capital expenditures are approximately 15.2% of total budget, excluding \$549,605 in commitments for vehicle replacements. Delivery dates for vehicles are at this time unknown due to factory closures during the Covid-19 pandemic.

Operating expenditures are slightly below budget at approximately 35.1%. The net financial position of 35.2% is approximately 0.5% below budget. This is in part due to the timing of retirements and availability of replacements, as well as unexpected cost savings and expenditures as a result of the Covid-19 pandemic.

SUMMARY:

2020 operating expenditures represented 35.1% of the total operating budget, slightly below budget. Revenues are below budget, mostly due to reduced special duties as ferries to the US have been suspended as well as many public events. Grants revenue includes \$133,200 of provincial funding for E-Ticketing implementation, which is underway.

Salaries are below budget by approximately 0.7%. Retirements are above budget due to the bulk of retirements occurring in the first quarter. We expect retirement expenditures to be over budget by the end of the year based on scheduled retirements. Retirement expenditures are primarily funded out of the operating budget. However, in the case of an operating deficit retirement may also be funded out of the Employee Benefit Obligation fund.

Overtime expenditures are slightly below budget due to reduced special duties. Overtime for Patrol backfill is however slightly overbudget. Overtime expenditures were also incurred in the first quarter in relation to protests. When adjusted for special duties overtime expenditures are approximately 0.5% over budget. Combined, salaries and overtime are slightly below budget at this time.

Approximately \$41,000 in overtime has been expensed in relation to decampment at Topaz Parka and Pandora Avenue. No revenue has been recorded against these expenditures as a funding mechanism has not been established by the Province at this time. We expect these costs will be reimbursed through a grant in the near future.

Building projects that were previously deferred will now hopefully commence in June. Vehicle delivery dates are still unknown at this point as car factories were closed temporarily in the spring due to Covid-19.

Pro-rated estimates have been included for expenditures that are billed annually or quarterly such as 9-1-1, CREST and allocations from the City for comparative purposes. The amounts for 9-1-1 do not include additional one-time staffing funding of approximately \$275,000 that was approved by the Police Board for 2020 as the exact amounts required have not yet been fully determined by E-Comm.

1. REVENUE

Revenues are below budget at this time as expected. Ferries from the US have been temporarily suspended. Many community events have also been cancelled or postponed. Due to Covid-19 we expect revenues and offsetting overtime expenditures to be significantly reduced.

Grant revenue includes \$133,200 received from the Province for the implementation of E-Ticketing.

2. SALARIES AND BENEFITS:

The Human Resources section recruits police officers based on a projection of retirements and authorized strength. As it takes at least 18 months for a recruit to be fully operational, VicPD tries to hire recruits ahead of anticipated retirements.

Salaries and benefits expenditures are below budget at this time due to the time lags involved in replacing retiring or injured officers. We will continue to monitor salaries and benefits expenditures but at this time expect to remain in line with the budget.

3. RETIREMENTS:

Retirement costs are \$460,657, representing 92.1% of the budgeted amount. Further planned retirements will bring us over budget, as expected, with overages to be drawn down from the Employee Benefit Obligation reserve if required.

4. **OVERTIME:**

Net overtime costs are below budget, partially due to a reduction in special duties. Special duties revenues are approximately \$100,000 below normal levels for this time of year due to the suspension of ferry services to the US and the cancellation or postponement of community events. Overtime for Patrol remains slightly above normal. Overtime costs were also incurred in the first quarter due to a number of protests within the City of Victoria.

5. PROFESSIONAL SERVICES:

Professional fees include the costs for Integrated Units, as well the costs to meet any unexpected legal costs. Expenditures, including estimates for unbilled Integrated Unit costs as well as services provided by E-Comm and the City of Victoria.

6. EQUIPMENT MAINTENANCE – FLEET & COMPUTERS:

Expenditures are slightly below budget due to reduced operations in the spring as a result of Covid-19. We expect expenditures to be on track as the year progresses.

7. TELEPHONE LINE CHARGES:

Telecommunication costs continue to be managed and a recent extension of the mobility contract has allowed us to realize additional savings on our telecommunication costs. Expenditures remain roughly in line with expectations at this time given the increased usage of data we expect during the Covid-19 pandemic as employees increase the amount of work performed remotely.

8. TRAVEL AND TRAINING:

Travel and training expenditures are below budget. We expect expenditures to remain below budget due to the significant number of cancellations of training and conferences due to Covid-19.

9. **BUILDING MAINTENANCE:**

Building Maintenance costs includes pro-rated year to date estimates.

10. GENERAL & OFFICE /OTHER OPERATING/UNIFORM & PROTECTIVE CLOTHING:

Other expenditures are in line with expectations at this time. Other operating expenditures include expenditures incurred for personal protective equipment, sanitation supplies and services to maintain hygiene during the Covid-19 pandemic. A portion of these expenditures will be recoverable through Emergency Management BC. Remaining expenditures will be offset by reductions in other expenditure lines to remain within budget. General and Office supplies expenditures includes expenditures incurred in implementing E-Ticketing, for which grant money was received.

11. FUEL AND MOTOR OIL

The majority of Fuel and Motor Oil expenditures are billed periodically through the City of Victoria. Expenditures are below budget due to reduced capacity at the City for non-essential maintenance, as well as lower fuel costs in the spring due to Covid-19. Although fuel prices remain below average, prices have increased in recent weeks.

12. DIVISIONAL BUDGET VARIANCES:

Budgets for police officer salaries are allocated based on deployment at the time the budget is prepared. Resources are re-deployed to other areas as required throughout the year. Variances can therefore occur where police officers have been moved in or out of units in the intervening period. The overall budget and actual deployment are both based on the number of authorized strength in the approved budget.

Youth Camp

Due to social distancing requirements the Youth Camp has been deferred to 2021.

Crime Prevention Services: School Resource Officers

The budget reflects the intent to reinstate the School Resource Officer positions. Due to resource constraints these positions have not been reinstated at this time.

Centralized Corporate Costs

Centralized Corporate Costs includes retirement expenditures for retirements as well as the costs to maintain public safety during protests in the first quarter.

Investigative Services: Crime Reduction Unit (CRU)

In June of this year the officers within the Crime Reduction Unit were reallocated to reinforce Patrol and Strike Force, as detailed in the Transformation Report. This unit remains temporarily suspended.

Special Duties

Ferries to the US have been temporarily cancelled, as have many community events for which policing is required.

Patrol

Previously additional police officers were reallocated from the School Resource Officers. These positions are still within the Patrol division at this time.

Traffic Enforcement

Expenditures include grant funded expenditures to implement the Provincial E-Ticketing initiative to stream line traffic enforcement

Dear Chief Constable Manak,

Thank you for your March 24, 2020 email providing feedback on any potential areas of concern related to the City of Surrey's policing model transition. At this time, it is expected that Surrey's policing transition will be a staged process, thus ensuring an adaptable approach to maintain adequate levels of policing and law enforcement throughout the lower mainland and the Province.

Further, the Justice Institute of British Columbia (JIBC) has conducted a comprehensive analysis of potential impacts to the Police Academy as a result of the Surrey policing transition. My team is now reviewing the reports and will work collaboratively with the JIBC to ensure that capacity requirements are met for the onboarding of new officers, as well as for advanced training requirements.

A policing transition of this magnitude requires careful consideration and navigation of a multitude of complex issues, and your feedback is tremendously helpful in our efforts to ensure that public safety is maintained. HIGHLIGHTS FROM Q1 REPORT

Property Crime Spike (Pages 3 & 6 of report)

The most notable aspect of this report is the increase in property crime in Esquimalt and Victoria. The increase includes business break and enters, residential sheds and underground parking thefts, theft of and theft from auto, shoplifting, and frauds. This increase was noted before COVID restrictions hit the region but it appears to have distributed the property crime from downtown. Of note, since financial assistance was provided (i.e. CERB) there has been a downturn in property crime noted. This is not considered a trend yet but it is worth watching.

Sexual Assaults in Esquimalt (Page 2 of report)

The statistical increase in sexual assaults was concerning even though the empirical numbers were low. A review was conducted of each case and there were no linkages or predatory concerns identified. This category will continue to be monitored closely. (Note: 1 Stranger assault facilitated through on-line dating).

Child Pornography in Victoria (Page 6 of report)

This increase resulted from targeted work from the SVU section. Our ICE investigator partnered with other SVU members to work on self-generated files.

CRIME TRENDS - VICTORIA

Overall

- 6% increase in overall number of occurrences
- 14% increase in Section 28, Form 21 and Form 4 of the Mental Health Act

Property Crime

- 34% increase
 - o 20% increase in Arsons
 - o 260% increase in Business Break and Enters
 - 150% increase in Residential and Other (sheds, underground parking garages) Break and Enters

- Overall in 2019 we were averaging less than 2 break-ins per day in Victoria. In 2020 that has increased to 4 break-ins per day.
- Overall Frauds were down but frauds using someone else's identity were up by 276% these were mainly "tap" frauds where someone steal another's credit or debit card and
 taps the machine vs. typing in a Pin.
- Theft of Vehicle was up 218% was big problem for us and it was mainly 2-3 offenders doing a bulk of the vehicle thefts
- Theft from auto was up by 7% (averaging about 6 cars being broken into each day)
- Bike theft has increased by 45%

Crimes against Persons (Violence)

- Increase in violent occurrences of 33%
 - Assaults were up by 40%
 - o Robberies were up by 14%
 - Threatening the safety of or violence to another was up by 53%
 - Sex related occurrences were up by 6%
 - Sex trafficking is up by 300% (1 call in Q1 of 2019 vs. 4 calls in Q1 of 2020)

Public Disorder

- Decrease in public disorder calls by 7%
 - Overall, 16% decrease in Public drinking/intoxication, by-law complaints and unwanted persons
 - Increases in disturbances of 300%
 - o Civil and domestic disputes (no violence) up by 21%
 - o Breaches of bail, probation and Peace increased by 21%

CRIME TRENDS - ESQUIMALT

Overall:

• 15% increase in occurrences in first quarter of 2020 compared to 2019

Property crime

- 89% increase in property crime
 - o 18% increase in break and enters (residences and underground parking garages)
 - o 247% in thefts form vehicles
 - Mischiefs up by 30% (e.g. smash windows, graffiti)

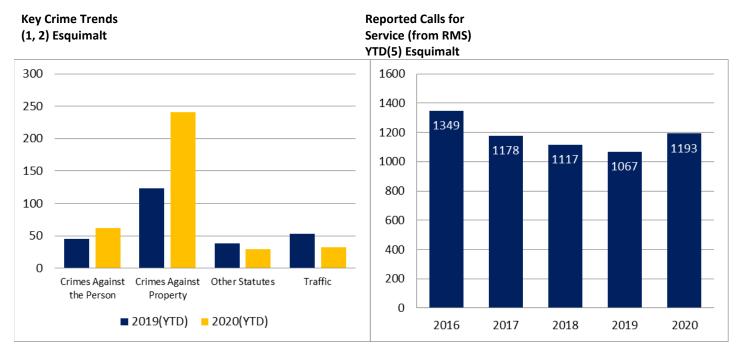

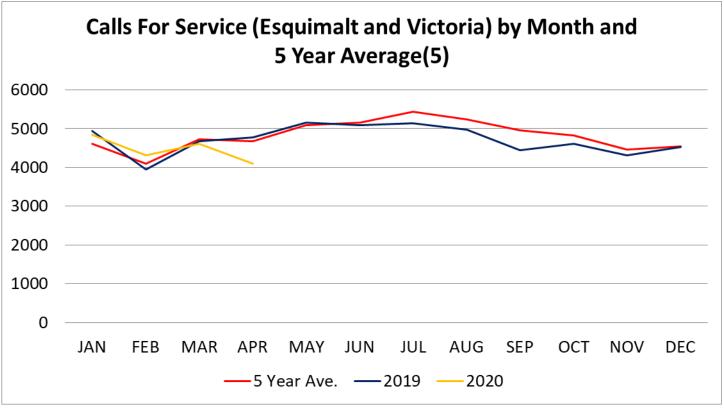
- 56% increase in crimes against persons (violence)
 - Harassing communications (e.g. emails, social media, etc.) up by 11%
 - Uttering threats against another doubled (increased by 100%)
 - Sex related offences were up by 300% (numbers are small -went from 2 in 2019 to 8 in 2020)

Public Disorder

- Decrease of 6% in the first guarter of 2020 compared to 2019
 - Decreases in noise and by-law complaints (44% decrease)
 - Neighbour and domestic disputes (no violence) were down by 28%
 - Drinking in public, disturbances and landlord/tenant disputes were up by 52%

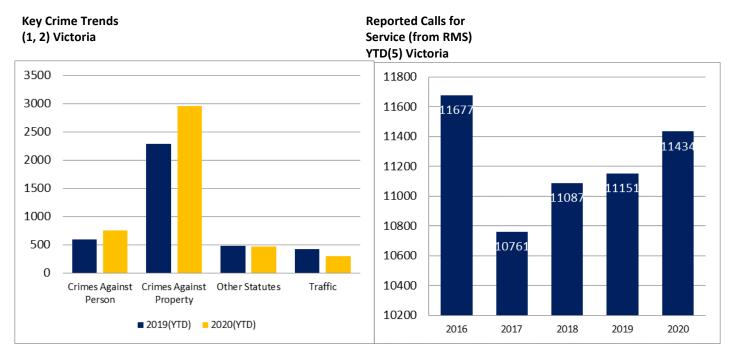

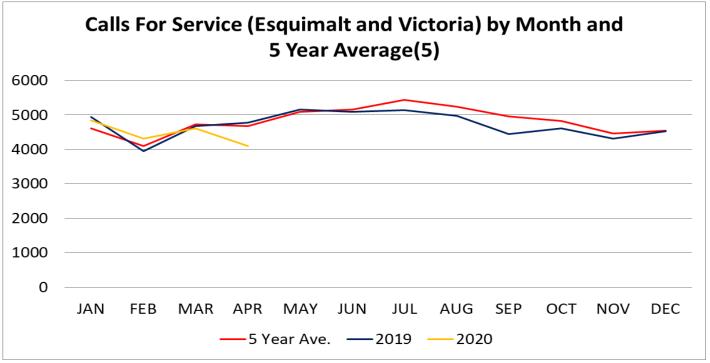
