#### 3. NEW BUSINESS

#### a. Police Tactics

Refer to the PowerPoint presentation provided. Cst. Roy, VicPD Use of Force Coordinator and GVERT member, provided an update regarding the level of accountability required by law when police members use force. Common law duties include: preserve the peace, protect life & property, prevent crime, enforce the law, and apprehend offenders. Reference was made to the requirements of the Criminal Code, the legal aspects of use of force, the national use of force framework, training standards, and the reporting thresholds.

In 2019, VicPD created occurrence reports for 56,000 calls for service and 810 Subject Behavior Officer Response reports were created.

#### b. GVERT Operations

Insp. Brown provided a historical overview of how the Greater Victoria Response Team was created in 1976 and the rationale for doing so. He outlined the composition of the team and the types of calls GVERT is deployed to which include barricaded suspects, arrests with armed confrontations, execution of search warrants, arrests of violent individuals, VIP protection, assisting K9 for high-risk tracks, and high-risk prisoner transport. He advised that the Armoured Rescue Vehicle (ARV) is most commonly used to enhance communications during barricaded suspect calls. The ARV is only deployed as required and its deployment statistics will now be documented.

#### **BACKGROUND:**

This report contains the financial results for the period ending August 14<sup>th</sup>, 2020, representing approximately 62.5% of the payroll year. Net operating expenditures are in line with the budget at this time and we expect them to remain so, although expenditures as a result of the Covid-19 pandemic are difficult to predict and unforeseen events may alter future forecasts.

Capital expenditures are approximately 74.7% of total budget, including commitments for vehicle replacements. Previous delays in vehicle deliveries appear to be resolved. Additional furniture expenditures have been incurred as a result of Worksafe compliance requirements due to social distancing requirements in relation to the Covid-10 pandemic.

Operating expenditures are in line with the budget at this time. The net financial position of 62.5% is as expected given the uncertainties faced with Covid-19. We will continue to monitor financial performance closely.

#### **SUMMARY:**

2020 operating expenditures represented 61.9% of the total operating budget. Revenues are below budget due to reduced special duties as ferries to the US have been suspended as well as most public events. Grants revenue includes \$133,200 of provincial funding for E-Ticketing implementation, which is underway. Additional funding has also been received for a civilian position through the Province of BC.

Salaries are below budget by approximately 0.2%. However, retirement expenditures are above budget. Should there be insufficient funds at year end to cover these overages, based on current expenditures up to \$160,450 in funds may be withdrawn from the Employee Benefit Obligation

fund, representing the amount in excess of the approved budget. The fund balance current sits at approximately \$8.08 million.

Overtime expenditures are above budget at this time. This is due mostly to ongoing front- line staffing shortages and additional call loads. Overtime expenditures were also incurred in the first quarter in relation to protests. Expenditure claims have also been submitted for costs associated with the decampment at Topaz Park.

Some funding was approved for Personal Protective Equipment and cleaning costs associated with Covid-19 through Emergency Management BC. As of May, additional funding requests are not being approved and we do not expect any additional funding for Covid-19 related expenditures from that point on. A separate report will be prepared detailing Covid-19 expenditures to date, approved funding and expected costs to the end of the year.

Building projects that were previously deferred are now underway and are expected to be completed on time. This will allow us to provide better safety for our staff during the Covid-19 pandemic as well as tackle some of our space issues. Some additional work will be performed in October when the required furniture arrives to increase social distancing and meet Worksafe requirements where shortfalls have been identified in specific work areas.

Pro-rated estimates have been included for expenditures that are billed annually or quarterly such as 9-1-1, CREST and allocations from the City for comparative purposes. The amounts for 9-1-1 includes an estimated amount for additional one-time staffing funding of approximately \$275,000 that was approved by the Police Board for 2020 as the exact amounts required have not yet been fully determined by E-Comm.

#### 1. REVENUE

Revenues are below budget. Ferries from the US remain suspended and most community events have been cancelled through to the end of the year. Due to Covid-19 we expect revenues and offsetting overtime expenditures to be significantly reduced.

Grant revenue includes \$133,200 received from the Province for the implementation of E-Ticketing. An additional \$115,400 in grants has been received from the Province to fund a civilian position and overtime from the Guns and Gangs Violence Action Fund.

#### 2. SALARIES AND BENEFITS:

The Human Resources section recruits police officers based on a projection of retirements and authorized strength. As it takes at least 18 months for a recruit to be fully operational, VicPD tries to hire recruits ahead of anticipated retirements.

Salaries and benefits expenditures are slightly below budget at this time due to the cancellation of the September class and the impact this has had on hiring for the Special Municipal Constables program due to the unplanned retention of recruits. We will continue to monitor salaries and benefits expenditures but at this time expect to remain slightly below budget.

#### 3. RETIREMENTS:

Retirement costs are \$660,450, representing 132% of the budgeted amount (\$160,450 over budget). No further retirements are expected for the remainder at the year. Should there be insufficient funds in the operating budget the amount over budget can be accessed from the Employee Benefit Obligation Reserve.

#### 4. OVERTIME:

Net overtime costs are over budget despite the reduction in special duties. This was partly due to protests in the first quarter, resulting in approximately \$207,000 in overtime costs. Additionally, costs were incurred for decampment of \$61,000 that have yet to be recovered from the Province, of which approximately \$20,000 has been deemed ineligible by the Province for reimbursement.

Backfill costs for Patrol due to continuing high levels of officer injuries have also resulted in higher than expected overtime costs. At the current trajectory Patrol overtime will be \$300,000 over budget by the end of the year. This is offset partially by below budget

amounts of overtime in other departments, cost savings from salaries, benefits and reduced training expenditures due to Covid-19 restrictions on travel and social gatherings.

Should we experience a surge in Covid-19 this fall contingencies are in place to maintain minimum front-line staffing. The cost of such actions will depend on the extent of any resurge in Covid-19 cases locally.

#### 5. PROFESSIONAL SERVICES:

Professional fees include the costs for Integrated Units, as well the costs to meet any unexpected legal costs. Expenditures, including estimates for unbilled Integrated Unit costs as well as services provided by E-Comm and the City of Victoria.

#### 6. EQUIPMENT MAINTENANCE – FLEET & COMPUTERS:

Expenditures are in line with expectations as we get back on track with planned purchases.

#### 7. TELEPHONE LINE CHARGES:

Telecommunication costs continue to be managed and a recent extension of the mobility contract has allowed us to realize additional savings on our telecommunication costs. Expenditures remain below budget.

#### 8. TRAVEL AND TRAINING:

Travel and training expenditures are below budget. We expect expenditures to remain below budget due to the significant number of cancellations of training and conferences due to Covid-19.

#### 9. BUILDING MAINTENANCE:

Building Maintenance costs includes pro-rated year to date estimates.

#### 10. GENERAL & OFFICE /OTHER OPERATING/UNIFORM & PROTECTIVE CLOTHING:

Other expenditures are in line with expectations at this time. Other operating expenditures include expenditures incurred for personal protective equipment, sanitation supplies and services to maintain hygiene during the Covid-19 pandemic. A portion of these expenditures will be recoverable through Emergency Management BC, although funding ceased as of May. An additional janitorial shift has been added to assist with decontamination of the fleet and additional cleaning throughout the building. Specialized equipment has also been purchased to sanitize the building. General and

Office supplies expenditures includes expenditures incurred in implementing E-Ticketing, for which grant money was received.

#### 11. FUEL AND MOTOR OIL

The majority of Fuel and Motor Oil expenditures are billed periodically through the City of Victoria. Expenditures are below budget due to reduced capacity at the City for non-essential maintenance, as well as lower fuel costs in the spring due to Covid-19. Although fuel prices remain below average prices have increased from those lows.

#### 12. <u>DIVISIONAL BUDGET VARIANCES:</u>

Budgets for police officer salaries are allocated based on deployment at the time the budget is prepared. Resources are re-deployed to other areas as required throughout the year. Variances can therefore occur where police officers have been moved in or out of units in the intervening period. The overall budget and actual deployment are both based on the number of authorized strengths in the approved budget.

Variances in overall financial performance reflect the redeployment of deployable resources to the front-line, represented by higher than budgeted expenditures for both Patrol and Community Services Division, below budget expenditures for Crime Prevention and Crime Reduction. This is in line with the Transformation Report presented to the Board to manage limited resources and increases in frequency and duration of injuries to police officers.

#### Youth Camp

Due to social distancing requirements the Youth Camp has been deferred to 2021. The deposit for 2020 has been carried forward to 2021 accordingly.

#### Crime Prevention Services: School Resource Officers

The budget reflects the intent to reinstate the School Resource Officer positions. Due to resource constraints these positions have not been reinstated at this time.

#### **Centralized Corporate Costs**

Centralized Corporate Costs includes retirement expenditures for retirements as well as the costs to maintain public safety during protests in the first quarter.

#### Investigative Services: Crime Reduction Unit (CRU)

In June 2019 of this year the officers within the Crime Reduction Unit were reallocated to reinforce Patrol and Strike Force, as detailed in the Transformation Report. This unit remains temporarily suspended.

#### **Special Duties**

Ferries to the US have been temporarily cancelled, as have many community events for which policing is required.

#### **Patrol**

Previously additional police officers were reallocated from the School Resource Officers. These positions are still within the Patrol division at this time. Patrol also includes members assigned to the Investigations Support Unit performing light duties.

#### **Traffic Enforcement**

Expenditures include grant funded expenditures to implement the Provincial E-Ticketing initiative to stream line traffic enforcement

#### **BACKGROUND:**

Covid-19 continues to present unique challenges to to provide services keeping our employees safe.

Below is a summary of the expenditures incurred to date, as well as amounts approved for recovery from Emergency Management BC (EMBC) through the City of Victoria's Emergency Operations Centre. A total of \$184,226 has been spent to date on supplies, capital and additional janitorial expenditures of which between \$54,990 and \$74,250 will be recoverable, depending on whether EMBC will remove a condition on the approval for surgical masks.

We have been informed by the City that EMBC will not approve any further expenditures for reimbursement. Net expenditures will therefore need to be absorbed within our existing operating and capital budgets.

#### **SUMMARY:**

Total expenditures to date are:

Janitorial	36,392
IT equipment & software	8,300
Boom microphones (radios)	55,576
Personal protective equipment	75,818
Car disinfection contract	8,140
Total	184,226

Expenditures incurred to date include the purchase of boom microphones for hygiene purposes (to go from pooled to individual issue) for a total expenditure of \$55,575. These amounts have been charged to the operating budget, although they may be charged to capital if there are insufficient funds in the operating budget.

Emergency Management BC (EMBC) approved a number of expenditures initially, including a number of personal protective equipment (PPE), janitorial and car disinfection costs. Of the \$74,250 approved \$19,260 included the purchase of surgical masks, contingent on purchasing supplies through the provincial government. Due to supply problems at that time and the urgent need for PPE this was not possible and masks were purchased instead through private channels. It is yet to be determined whether EMBC will reimburse us for those expenditures.

In addition to the amounts listed \$16,278 of the costs related to policing the decampment of Pandora and Topaz Park will not be recoverable. At the time the details of funding from the Province were not known and a portion of the overtime was retained by members instead of being paid out. The Province has subsequently declined to reimburse us for any overtime that was not paid out when earned.

The current supply of personal protective equipment is adequate. Additional janitorial services from the City of Victoria consisting of one additional shift 5 days a week is ongoing for a monthly cost of approximately \$7,700. This includes disinfection of the fleet using electrostatic and City staff for a lower cost than the previously contracted service.

Although we are well stocked further expenditures may yet be incurred, depending on factors such as the duration and impact of the pandemic on personnel or changes in recommended PPE or other safeguards.

#### FINANCIAL IMPACT:

The net financial impact on the Department is expected to be approximately \$175,000 by the end of the year, offsetting much of the cost savings from training and travel due to the deferral of training due to Covid-19 restrictions on travel and gatherings. We will continue to monitor expenditures as the situation evolves.

Dear Minister Farnworth,

As the Minister for Public Safety, I wanted to bring to your attention concerns I am hearing from my constituents in the Burnside-Gorge neighbourhood about the need for additional policing resources.

I know that the Director of Police Services is conducting a review following an application from the Victoria and Esquimalt Police Board under Section 27 (3) of the Police Act to determine if the current funding is sufficient to provide an appropriate level of policing.

Residents have expressed their view that the increased demands on policing to protect public safety and to work with vulnerable populations during the COVID-19 pandemic in Victoria's downtown and residential neighbourhoods has demonstrated a growing need for additional resources and as such, the Burnside-Gorge residents are hoping for a timely conclusion to this review.

In particular, additional policing is important for these residents and for those sheltering in parks, so that officers are available to support the safety and wellbeing of the residents and those living outside, including supporting the work of mental health, housing, and outreach workers through the Assertive Community Treatment (ACT) Teams.

We all have a shared responsibility to support our most vulnerable citizens as we together deal with the COVID-19 pandemic. Part of this support has meant meeting the immediate need for emergency housing accommodations with wraparound supports as part of our public health response. I am pleased that BC Housing has proactively convened a Community Advisory Committee of residents, business owners, city officials, police, service providers and health authority professionals that has served as a valuable forum for my constituents to share their experiences and concerns. I also want to acknowledge the work of the agencies who are providing 24/7 wraparound supports to vulnerable people living in hotels.



I note that the Victoria Police Department has been able to address the immediate requests for more frequent and visible patrols in the Burnside-Gorge area through redeployment of officers via the reallocation of internal budget resources. However, it is important to be aware that Victoria's Chief of Police indicates that this may not be financially sustainable after the second week of September. I am encouraged that the Victoria City Council will be debating a motion next week to fund a continuation of this increase in local patrols to the end of the year.

I thank you for your attention to the public safety concerns that have emerged during the pandemic and the desire of local residents for a timely resolution of the ongoing review.



Each time it looks like the situation I have just described: Caring men and women putting themselves in harms way while using intuition, respect, compassion and strong policing skills to keep our community safe.

I have experienced and have witnessed quite the opposite than what is portrayed in the news day after day. With recent world events, there has been an increased focus on Peace and Police Officers in British Columbia and around North America. The result has been debate on funding models for law enforcement activities, alternate responses to mental health emergencies, police oversight and general policing practices.

Unfortunately, there has also been an increase in statements and positions not based on empirical evidence or fact, but on an emotional response. The level of negativity towards peace and police officers in British Columbia has also risen dramatically, including social media postings, protests and verbal abuse at police officer's places of work and even activities that, at any other place of employment or public space, would be considered inappropriate at best and harassment by most.

While we do not condone racism or abuse of power, vilifying the men and women who put on a uniform every day and are asked to protect citizens and promote order is not productive, nor beneficial in addressing the issues. The overwhelming majority of peace and police officers go to work every day to serve and protect in extremely difficult and challenging work environments with integrity and pride.

The Ambulance Paramedics and Emergency Dispatchers of BC have had a close working relationship and bond with peace and police officers since the creation of the BC Ambulance Service in 1974. Multiple times every day, they assist and protect us on calls, many of which are related to mental health emergencies. While we have always advocated for greater access to mental health and addictions professionals for patients in crisis, the fact is, many of these calls are volatile and potentially violent and require law enforcement intervention for everyone's protection. One only needs to look at the specialized units in BC policing that utilize a specially trained medical professional paired with a police officer and the successes of those units.

Peace and Police officers have protected us, served alongside us and supported us during our darkest times. These women and men are integral to a safe and just society and do not deserve to all be stereotyped in a negative way based on the actions of a few.

It is a difficult job to be a police officer in the best of times, and right now, police forces are facing unprecedented negativity.

We are thankful and grateful of their service and believe the public should be as well.
