Dear Victoria Police Board,

I am writing this letter to provide you with a description of our work with the Victoria Police Department (VicPD) in 2018 and highlight the members of the department who have been especially instrumental in our partnership and success.

As you will note in the tables below, in 2018 VicPD referred 112 offenders who committed a total of 121 offences, which made up 82% of the referrals our organization received last year. This is the most files we've ever received in a year from VicPD (see Appendix A for a yearly chart of all VicPD referrals since 2006) and over doubles our typical annual referrals from the department. We're extremely grateful that members continue to send us a variety of offences and are keeping victims' needs in mind when considering whether restorative justice is an appropriate response to a crime.

In 2018 we conducted a second distracted driving seminar. The first seminar took place in 2017 and was hugely successful so this event was designed to build on that success and further evaluate the effectiveness of this approach in reducing risks on the road, encouraging behaviour change, and a change in attitudes among drivers and their peer group. The 2018 event took place on November 1st and 39 ticketed drivers attended in lieu of paying a fine. Anecdotal evidence and surveys completed by the participants indicated that the event was very successful in shifting participants' perspectives on distracted driving and increasing their sense of responsibility behind the wheel. Quotes from the surveys participants completed at the end of the session are on page 7-8 of this document. We've now sent out the 3 and 6-month evaluations via email and highlights from those include that 91% indicated their behaviour has changed; 100% have not received a distracted driving citation since; and, 100% think that the pilot program can help reduce distracted driving among distracted drivers. A final email survey will be conducted at the 1-year mark to determine the long-term success of the project.

Also in relation to the distracted driving seminars, we were pleased to be able to support Chief Manak in developing his speaking notes for his presentation on the distracted driving project to The Canadian Association of Chiefs of Police (CACP) at their annual conference in Halifax, NS in August. We hope other departments, provinces, and territories will also see the benefits of using education as one component in curbing this dangerous behaviour.

In 2018, the Police Board asked us to consider how our organization might be able to assist with missing youth, as this issue is dangerous for the youth and also results in significant

resource expansion from the department. As an organization we discussed what we might have to offer and made a formal presentation to the Senior Management Team on June 6. Chief Manak followed up with me after stating that he would present the material to the board and be in touch if anything further was required. We never heard anything back and are hopeful that the department is identifying effective ways to address this behaviour to alleviate the risks to youth and costs to the department.

We were asked to present twice to the watches in 2018. We did a presentation on January 17 that was coordinated by Jeremy Preston and another on December 10 that was coordinated by Sean Cowperthwaite. We greatly appreciate the opportunity to speak directly to patrol members about our program and answer questions so will schedule more of these briefings in 2019.

I presented to the Police Board twice in 2018. The first was on May 15 when I presented our work with VicPD in 2017. The second was on December 18 when I, along with Shannon Perkins and Sean Millard, presented on the distracted driving seminars. I always appreciate the opportunity to speak directly to you about our work.

We were invited to attend VicPD's retirement party on February 1. I was unable to attend due to childcare issues but some of our staff went. We enjoy spending time with members outside of work. We appreciate the relationships that we have developed with both members and civilian staff and recognize the value of these relationships in our ongoing work together.

Throughout 2018, our staff continued to attend the department on Tuesday and Thursday mornings. Due to a shift in my schedule, for 2019 those times will change to Monday and Thursday mornings from 9:00am-10:30am. Also, we did presentations with Cst. Millard to all new recruits during their department orientation.

There were numerous police and civilian members of VicPD who have been immensely helpful to our work this past year. I would like to take this opportunity to highlight them.

Cst. Sean Millard has been our police liaison officer since 2014. Sean has been an incredible source of support to our staff and volunteers and has been an effective champion of restorative justice within the police department. His dedication to our program has changed the hearts and minds of members and helped us create practices and protocols that have streamlined our work and addressed unresolved issues. Sean reported to me that in 2018 he frequently fielded questions from members about our program generally and specific cases they were considering for restorative justice, and also approved files for members. His assistance in these areas is paramount and the importance of this role cannot be overlooked, as it's required to maintain and increase the support and knowledge of our services within the department. Sean also conceptualized the distracted driving

project, which has been a huge success and has allowed us to explore the use of restorative principles in a unique environment. This pilot also created a great deal of positive media for RJV and the department. We cannot put into words the gratitude that we have for Cst. Millard and we want to express our appreciation to the department in supporting his work with us.

Sgt. Shannon Perkins was also a significant part of the distracted driving seminar; she and her team distributed the tickets and registration forms. Ins. Jamie Pearce came down to Esquimalt City Hall to support me in my presentation to council for funding in 2018. Deputy Chief Jason Laidman has continued to be a support to us. I met with him on December 5th to discuss our program and the distracted driving project. We greatly appreciate leadership within the department having buy-in for and supporting our work.

Evaluation of Community Impact

Our thorough three-point evaluation system ensures that we get rich feedback from clients at multiple points throughout their participation in our programs, as well as two months after the files are closed. We regularly review the feedback and adjust our processes based on the findings. In 2018, as in other years, we had extremely positive feedback, with almost all clients reporting being "satisfied" or "extremely satisfied" with the services that they received.

Below are some comments that clients made in their evaluations from 2018.

- "I don't think that I would have experienced the level of genuine warmth, empathy, understanding and respect if I had gone through the court system. I think the courts would have tried, but I don't believe I would have received the degree that was needed regarding my incident."
- "Restorative justice helped me understand what I did wrong and how it affected
 people and the community. With help from the staff I was able to take full
 responsibility for my actions and worked towards fixing the problem that I caused."
- "Creates better understanding of the context of the crime. Meeting the person putting a face to the offence, hearing remorse helps the victim."
- "As I take responsibility for my actions, the incident was a wake-up-call for my high stress life and shone a light on the fact that I was not taking good care of myself. The restorative justice program helped me take a much clearer look at what was happening in my life and helped make some necessary changes."
- "...I was able to reflect upon myself and realise how badly my life was going and work on it. I was able to turn it around and become a better person."
- "Restorative justice, although daunting at first, treated me with a high level of professionalism and respect. They were warm, kind and very understanding and allowed me so much time to establish trust for the process."
- "I'm able to control my alcohol intake better now, and diffuse rage before it gets explosive."
- "I just feel like a better person all around."

- "[in court] I don't think that myself and the other party would have been able to talk
 frankly and be able to speak openly about issues and then shake hands, apologize
 where necessary and walk away feeling as though we are now friends."
- "Being 'forced' to talk about the process, my emotional state, etc. has helped me come to terms with my one terrible decision and realize that it doesn't define me or wholly change me as a person."
- "I've come to better terms with a lot of past trauma."
- "[in court] I don't think my mental health would be addressed as thoroughly like restorative justice addressed it."
- "A beautiful, positive, constructive way of addressing all sorts of detrimental emotions and thoughts."
- "No one shamed me for what I did. Just helped me."
- "I was surprised about how great the restorative justice system is and works. I have never heard about it until this situation and I am very pleased with how it deals with these types of crimes and situations."
- "Long process but it has proved to help me feel more motivated to change. I've had
 to look back why I'm in this situation in the first place so completely this will go a
 long way. RJV helped me.

Distracted Driving Pilot Project

People who attended the 2018 distracted driving seminar completed an anonymous survey at the end of the session and delivered the following quantitative feedback:

- 97% said that they will you now change their behaviour and/or say something to their family
- 92% said they now possess a greater understanding of how distractions negatively affect driving skills and abilities
- 97% said they would recommend this seminar to others

Below are some quotes from participants:

"Will change my life and possibly many more."

- "I strongly believe need more research about cognitive cause including been desentitive to what happens to others. This happening around the world including some kind of selfishness or lack of empathy. We do tend to trust our "autopilote" and think we can multitask."
- "Thank you for forcing me to change my bad habits. This has been a problem for me for years. No longer. I appreciate all the time you've put into this. This is way more effective then ticketing. (Though that motivated me to be here.)"
- "The intensely compelling combination of story as well as statistics not just "solo" storied etc. Had a much more profound effect on my stance then had I simply paid a fine and been handed a punishment. To be honest those would have an almost opposite rebellious effect than being given areal set of statistics and research to root firmly in my mind."

In the early hours of May 19th my store was broken into



Chief Manak,

On Saturday June 22, 2019, a protest march took place along seven kilometers of highway, across three jurisdictions; starting in Victoria at Centennial Square, through the Municipality of Saanich, and ending at Island View Beach in Central Saanich. The march was organized by a group known as *Rise and Resist* and their purpose was to publically protest the Trans Mountain Pipeline project approval.

In the days that preceded the protest, our staff became aware of its existent through the efforts of Sgt. Cliff Watson and Cst. Dan O'Connor (Division Liaison Team members). Through their efforts, pre-event information was received from the protest organizer regarding the route, numbers of anticipated participants, and their goal for the protest. This information enabled our staff to prepare an accurate operational plan and properly resource the day.

On the day of the event, Sgt. Watson and Cst. O'Connor not only liaised with our staff (including an in-person visit when the march passed Saanich PD), they also maintained constant communication with our site supervisor and Incident Commander, and walked with the protest group for the entire route. By directly participating in the march, Sgt. Watson and Cst. O'Connor were able to supply first hand observations of the group's activities throughout the day, and render advice with respect to police resource deployment as the march progressed. One example of this included Sgt. Watson informing our members when a conflict broke out between a protestor and a motorist,

enabling our members to respond in a timely manner and effectively manage the conflict before it escalated. In addition, knowing where the protestors were on the route, whether they were sitting down in an intersection or stopped for a rest, greatly assisted our command element and staff understanding of what was transpiring. This knowledge enabled our members to maintain a lower profile when they were not required to block roads, as they knew they would receive early notification from Sgt. Watson when the group was on the move again. Sgt. Watson also received information from the regarding police activities they did not agree with. He was able to explain to the why police were engaging in certain activities and make suggestions for alternate response options to foster a better outcome for both sides.

I cannot stress enough the benefit of the intelligence and overall assistance the DLT officers were able to provide, and the positive impact it had on the success of the operation in all three jurisdictions. It enabled our Incident Commander, Insp. Edwards, to fully understand what was occurring during the march, and direct resources accordingly.

On behalf of the Mayor, Council, Police Board, and the department, I want to sincerely thank Sgt. Watson, Cst. O'Connor, and your department for your invaluable assistance on June 22, 2019.

I sit on the Trauma Informed Practice (TIP) Steering Committee on behalf of the BCAMCP. The TIP project is a five (5) year initiative funded by the Department of Justice Canada. The goal of the project is to develop trauma-informed best practices for justice-related professionals including Police, Victim Services, Crown Counsel, Corrections and others.

As part of the project, the Steering Committee assisted in the development of TIP foundational (multi-sector) and sector-specific training curriculum scheduled to be delivered on-line (CPKN) and in-person (JIBC) in 2019. The foundational and sector-specific police training is anticipated to become mandatory for police in the province. The training will help educate police on the impacts of trauma in many dimensions including, but not limited to, intergenerational trauma, PTSD, victim responses, victim statements, and victim testimony in court.

As part of the on-line curriculum development, RCMP C/Supt. Dave Attfield and I were asked by the committee to identify eleven (11) municipal police officers and eleven (11) RCMP officers to complete the pilot on-line CPKN training modules and provide feedback. The time required for each member to review the foundational and police sector CPKN training modules was estimated to be eight (8) to ten (10) hours in duration.

Cst. Ross Smith participated in, and completed, the pilot on-line CPKN training and we are extremely grateful for his time, effort, and contribution to training that was somewhat lengthy and onerous. Today's policing world is extremely busy and requests like these often exacerbate individual capacity and workload. Cst. Smith completed this task professionally and without complaint and, as a result of his efforts and the efforts of the other participants, the training is now ready to be rolled out across the province.

Subject: Facial Recognition Technology use in Victoria

To: Chief Constable Del Manak, members of the police board; Mayor Barbara Desjardins, Mayor Lisa Helps, Brian R.D. Smith, Patti Stockton, Sean Powell, Keven Elder, and Evan Southern and whom it may concern,

I am writing in regards to Facial Recognition Technology (FRT). I think that the Victoria Police Department has a responsibility to write a policy on Facial Recognition Technology that addresses both how the Department may use this technology as well as how the technology is being used by non-governmental and private entities within the city.

There is no doubt a robust debate to be had about why facial recognition technology is or isn't different from other surveillance and to what degree. This debate could be informed by existing Freedom of Information legislation or the spirit of it, the accusations that many FRT products on the market are racially biased and therefore unethical, the actions of the City of San Francisco to ban FRT, the more and more frequent instances of private security companies using the technology for their own purposes, or many other emerging criticisms on the ethics of growing surveillance capacity. The details of this debate are not important. The fact is that no matter which opinion prevails, police departments have a responsibility to be transparent in its use in order to effectively apply it in criminal deterrence and prosecution, and equally, to protect citizens from its misuse.

I urge the Victoria Police Department to write a policy and make a public statement on how Facial Recognition Technology is allowed or not, and used within Victoria for the purpose of informing the public of what their rights are, and what information is being gathered about them. While I don't currently know of Canadian federal or provincial legislation on the matter, I think that local levels of government still have a responsibility to be proactive and transparent in protecting citizens, and expect that local policies will push the agenda on a larger scale where research can be conducted and best practices can emerge through robust public consultation.

Dear Mayor Helps and Mayor Desjardins:

As you know, the Policing and Security Branch (PSB) has taken on a leadership role to strengthen police boards' ability to govern effectively by partnering with the Institute of Corporate Directors and Rotman Executive Programs to develop and deliver the first formal police board training program in Canada. This year the Province funded program tuition for at least two members from each police board.

The program curriculum was designed and delivered by subject matter experts in police governance and board effectiveness and includes key topics, such as: financial literacy for police board governance, police board members' responsibilities and accountabilities under the *Police Act*, strategic planning and effective governance in the police context, performance metrics for policing and law enforcement, stakeholder relations and evaluation of police chief's performance.

To accommodate board members on Vancouver Island and Lower Mainland, the training was delivered at the University of Victoria during May 3-5 and Simon Fraser University during June 8-9.

Considering the unique challenges that the Victoria and Esquimalt Police Board (the Board) has faced in recent years and ongoing developments around the police budget and the Framework Agreement, I was surprised to learn that the Board was the only municipal police board not represented at this year's training program.
